In order to effectuate its said desire the AUTHOR has handed over to the Trustees a sum of Rs.10,000 (Rupees Ten Thousand only) to hold and stand possessed for the same (hereinafter for brevity's sake referred to as "Trust Fund" which expression shall also include cash and any other property and investments of any kind whatsoever into which the same or any part thereof might be converted, involved or varied from time to time or such as may be acquired by the Trustees or come to their hands by virtue of these presents or by operation of law or otherwise howsoever in relation to these presents) upon the Trust and with and subject to the powers, provisions, agreements and declarations hereinafter declared and contained of and concerning the same.

The name of Trust shall be "SHREE RENUKA SUGARS DEVELOPMENT FOUNDATION".

The object for which Trust Fund is established is to promote education, healthcare, gender equality initiatives, development of water resources, training and assistance for employment – oriented / entrepreneurial / self help ventures and advancement of any other charitable objects of general public utility not involving the carrying on of any activity for profit and for such purposes.

- (a) To establish, maintain, and/or grant aid in cash and/or kind to hospitals, medical schools, medical colleges, nursing institutions, veterinary hospitals, charitable and/or traveling dispensaries, aftercare clinics, maternity homes, child welfare centres, orphanages, widows homes and/or such other similar charitable institutions in India for the benefit and use of the public in general.
- (b) To establish, support, acquire, run and/or grant aid and other financial assistance to schools, colleges, libraries reading rooms, hostel, boarding houses, laboratories and other institutions of like nature at any place or places in the Indian Union for use of the students and the staff and also generally for the development and/or advancement of education and diffusion of knowledge amongst the public in general.
- (c) To establish, maintain and/or run studentships, scholarships and render other kind of aid to individuals including supply of medicines, books, stipends, medals and other incentives to study, without any distinction caste, colour or creed.

- (i) To adjust, settle, compromise, compound, refer to arbitration, all actions, suits, claims, demands and proceedings regarding the Trust Fund.

It shall be lawful for the Trustees to give aid by way of donations out of the Income or the corpus of the Trust Fund or otherwise, to different charitable institutions, societies, organizations or Trusts in India which may have been established or which may hereafter be established for like charitable purposes mentioned in these presents or any of them to enable such institution, societies, organization or Trustees to start, maintain, or carry out such charitable objects as are mentioned in these presents or any of them.

- The Trustees shall be chargeable only for such moneys, stocks, (7) shares and funds as shall actually come into their hands and a Trustee shall not be answerable or accountable for neglect, default, acts or omission or commission of the other Trustees, nor of any banker or other person with whom the trust properties or any securities may have been deposited or kept.
- The Trustees will not be entitled to receive any remuneration, but the (E) Trustees may reimburse themselves all expenses actually incurred by them in connection with the Trust or their duties relating thereto.

The number of the Trustees shall not be less than two and more than seven. If the number of the Trustees shall fall below two, the Trustees shall not, except for the purposes of filing any vacancy, act so long as number is below the said minimum.

The Trustees for the time being with the consent of the Author will be at liberty to appoint additional Trustee within the number mentioned above, for such period or on such terms as to referement and reappointment, as the trustees for the time being consider proper. If any Trustee dies, retires, becomes unit or incapable to act, the continuing or surviving Trustee or Trustees will be competent to appoint a Trustee in place of the Trustees dying, retiring or becoming unfit or incepable to act with the consent of the Author, A person shall cease to be a Trustee either, (i) if he without leave of absence does not attend three consecutive meetings of the Trustees or for one calendar year, whichever is longer, or (2) if he is requested to resign by 3/4th or as near thereto as possible of the remaining Trustees.

- (13) The Trustees may from time to time frame rules for the conduct and regulations of the meetings of trustees. In the absence of such regulations:
 - (a) Two Trustees shall form a quorum for a meeting of the Trustees.
 - (b) All matters will be decided mutually by the Trustees.
 - (c) Resolutions passed without any meeting of the Trustees but by circulation thereof and evidenced in writing under the hands of twothirds of the trustees shall be as valid and effectual as a Resolution duly passed at a meeting of Trustees.
- The Trustees shall have the power and their uncontrolled discretion, instead of acting personally, to employ and pay an agent (including any Bank) to transact any business or to do any act whatsoever in relation to the Trusts of these presents, including the receipt and payment of moneys without being liable for loss, and shall be entitled to be allowed and paid all charges and expenses incurred thereby.

The Trustees may delegate in writing all or any of his powers under these presents to his nominee, who will be entitled so long as such nomination remains in force, to exercise such power or powers, in the same manner as the Trustee himself could do personally.

The Trustees shall have the power to determine in case of doubt whether any moneys or property shall for the purpose of the charity be considered as capital or income and whether out of income or capital any expenses or outgoings ought to be paid or borne and on every such determination shall be binding and conclusive provided that nothing contained shall be deemed to authorize the Trustees to spend the income or corpus of the Trust for any purpose not authorized by these presents.

(17) It shall be lawful for the Trustees to settle all accounts and to compromise, compound, abandon, or refer to arbitration any action or proceedings or disputes, claim, demand, or things proper for such purpose without being responsible for any loss occasioned thereby.
